Key Differences Between the Fulbright US Scholar Program and the Fulbright Specialist Program



The Fulbright program encompasses numerous initiatives; some enable American citizens to teach, conduct research, or complete projects abroad. Others bring visiting students and scholars to the United States to enhance campuses across the country with their skills and enthusiasm. With so many programs, occasionally there is confusion about which Fulbright might be the best fit. This handout explains key differences between the Fulbright US Scholar

Program (the flagship program for US faculty hoping to pursue Fulbright awards) and the Fulbright Specialist Program (a short-term option for experienced faculty with specific expertise to share).

Applicant selects and applies to only one award per cycle; most awards are for a single country. For multi-country projects, applicants should search for Global or multi-country awards.	Country Selection	Applicants with an interest in a particular world region or country may indicate preferences, along with relevant language proficiency, at the time of application. However, this will not guarantee placement in the desired country or region.
Award amounts vary by country, project length, and activity. Dependent allowance available for many awards.	Award Amount & Benefits	Round-trip economy class airfare between the US and host country; transit allowance; visa fees; daily honorarium; enrollment in a limited health benefits program; lodging; meals; in-country transportation. Dependent allowance is not available.

If selected, individuals remain on Roster for three years. There is no guarantee to be matched; individuals on Roster must be matched and complete an exchange to be considered a Fulbright Specialist.
